THE TOWN OF PICTOU, on behalf of its **WATER UTILITY** has applied for approval of amendments to its Schedule of Rates and Charges for Water and Water Services and amendments to its Schedule of Rules and Regulations

- You may request formal standing as an Intervener, subject to Board approval. This will allow you to present evidence or cross-examine witnesses. Your request must be received by the Board by Monday, March 29, 2021 and a copy of your written evidence by Wednesday, May 12, 2021.

Additional information about the matter is as follows:

For the unmetered rate, the current quarterly water bill is \$174.86, and it is proposed to increase to \$189.32 (an 8.3% increase) in 2021/22; \$199.47 (a 5.4% increase) in 2022/23; and \$208.64 (a 4.6% increase) in 2023/24.

For a 5/8 meter, residential customer, the average current quarterly water bill is \$125.87, and it is proposed to increase to \$135.0 (a 7.3% increase) in 2021/22; \$141.50 (a 4.8% increase) in 2022/23; and \$146.55 (a 3.6% increase) in 2023/24.

The Utility is also requesting increases for other metered services ranging from 4.9% to 8.3% in 2021/22; 3.4% to 5.5% in 2022/23; and 2.7% to 4.8% in 2020/21.

The annual fire protection charge paid by the Town, currently \$262,369, is proposed to be increase to \$277,477 (a 5.8% increase) in 2021/22; \$303,194 (an 9.3% increase) in 2022/23; and \$326,844 (a 7.8% increase) in 2023/24.

Upon reviewing the Application, the Board, in its Decision, may determine that the proposed amendments should be as requested, higher, or lower.
